

## POLICE BLOTTER 10/21/2024

Saturday, August 31, 2024, 1500 hours. Officers were dispatched to the 200 block of Hazel Avenue for the report of a **PAST TENSE BURGLARY** that had occurred during the overnight hours the previous night. One of the residents reported broken glass to a common door which leads to two separate apartments. It did not appear that either of those apartments were actually able to be entered, nor a third apartment with a separate entrance. Officers did observe the broken glass, and also located several areas of what appeared to be blood. It is suspected that due to the placement of the blood, that the blood may belong to the subject who broke into the apartment building. Officers and detectives gathered and secured the biological evidence with the intent of having it tested at the State Police Laboratory. Officers and detectives were also able to obtain video evidence from several cameras in the area. Anyone with any information regarding this case is asked to call the Delanco Police Department and ask to speak to a detective. This is an ongoing investigation.

Friday, September 6, 2024, 1532 hours. Officers on patrol in the area of Walnut Street and Burlington Avenue observed a pedestrian who was known to be wanted on an out-of-town **WARRANT**. Officers approached the male pedestrian and advised him of the reason that he was being stopped. Officers then confirmed the warrant via Central Communications, which had been issued out of Cinnaminson Township. Once confirmed, officers took the male into custody and transported him to Police Headquarters. The male was processed according to departmental policy and Cinnaminson municipal court was contacted. The Cinnaminson court administrator authorized the male to be released on his own recognizance (ROR) with a future court date. The male was given an ROR bail form with his court date indicated on it and released from custody.

Monday, September 9, 2024, 1047 hours. Officers were detailed to an online report that was filed concerning **FRAUD** and **IDENTITY THEFT**. Upon contacting the victim, officers were advised that a family member of the victim had been writing checks to herself from the victim's bank accounts and also withdrawing money from the victim's savings account. The fraudulent withdrawals added up to over \$2,600 in losses to the victim. It was also learned that the same family member had opened up at least 1 credit card account using the victim's personal information, and using that card to charge up over \$1,000 in fraudulent purchases. This case was assigned to the Detective Division and is currently being investigated.

Wednesday, September 11, 2024, 1631 hours. Officers were dispatched to the West Avenue Ball Fields and Nature Trails for the report of **CRIMINAL MISCHIEF** that was done to a storage shed that is used by Del-Riv Kids' Athletic League. During an unknown time frame, an unknown person or persons attempted to gain entry to the shed by damaging the handle to the garage-style door on the shed. It appears that the suspects attempted to remove the handle, which also damaged the garage door. Evidence was gathered and secured by the officers for further investigation.

Saturday, October 5, 2024, 1203 hours. Officers were dispatched to the area of Orchard Avenue and Vine Street for the report of a 2 car **MOTOR VEHICLE CRASH**. Upon arrival, officers spoke with the operators of both vehicles and determined that Vehicle #1 was traveling Northbound on Orchard Avenue when the operator of Vehicle #2, which was parked, opened the driver side door into traffic, where Vehicle #1 struck the door of Vehicle #2. No injuries were reported and information was taken to generate a crash report.

Monday, October 7, 2024, 1406 hours. Officers were dispatched to Police Headquarters for a report of a **FRAUD**. Upon arrival, officers spoke with the victim who reported that they had bought a trailer from a private party, however, were not given a title to the trailer. The seller promised to provide one at a later date, however, has not done so. After purchasing the trailer, the victim also noticed that the Vehicle Identification Number (VIN) had been scratched off of the trailer. An affidavit of probable cause was filled out and submitted to the court for a determination of probable cause hearing.

Wednesday, October 9, 2024, 1900 hours. Officers were dispatched to Police Headquarters for a report of a **THEFT** of money. Over the course of the past couple of months, officers were investigating a complaint of a theft of cash from a residence in the 300 block of Delaware Avenue. A male had been inside of the house and allegedly removed cash in the amount of approximately \$2600 from several different locations within the house. The male then replaced the money with counterfeit money. The walk in complainants filed an affidavit of probable cause which was submitted for a determination of probable cause hearing.

Sunday, October 13, 2024, 1053 hours. Delanco officers were advised that Riverton Boro Police Department had a subject in custody on a **WARRANT** out of this jurisdiction. Delanco officers took custody of the suspect from Riverton. Due to a medical condition, the suspect was release on their own recognizance (ROR) with a future court date.

Monday, October 14, 2024, 0857 hours. Officers were dispatched to the area of Burlington Avenue and Union Avenue for the report of a 2 car **MOTOR VEHICLE CRASH**. Upon arrival, officers spoke with both drivers and determined that Vehicle #2 was traveling Northbound on Burlington Avenue at the intersection with Union Avenue. Vehicle #1 was traveling Eastbound on Union Avenue, failed to observe the stop sign, and entered into the intersection, where he struck the side of Vehicle #1. No injuries were reported and information was taken to generate a crash report.

Tuesday, October 15, 2024, 1333 hours. Officers were dispatched to Police Headquarters for a walk-in complaint for **HARASSMENT**. Upon arrival, officers spoke with the victim who reported that he was being harassed and threatened over Facebook. The victim advised that he wanted to sign charges and

completed an affidavit of probable cause. The affidavit was forwarded to the court for a determination of probable cause hearing.

Wednesday, October 16, 2024, 1433 hours. Officers were dispatched to Police Headquarters for a report of a walk-in **HARASSMENT** complaint. Upon arrival, officers spoke with the victim who reports that for the past several months that he and his family have been continuously harassed by a neighbor. He reports that this neighbor comes to his house, yells out loudly to them, accuses them of committing crimes, and posts derogatory remarks on Facebook. The victim wished to sign charges and completed an affidavit of probable cause. The affidavit was forwarded to the court for a determination of probable cause hearing.
