**NOTICE OF PENDING BOND ORDINANCE AND SUMMARY  
ORDINANCE 2026-07**

The bond ordinance, the summary terms of which are included herein, was introduced and passed upon first reading at a meeting of the Committee of the Township of Delanco, in the County of Burlington, State of New Jersey, on May 4, 2026. It will be further considered for final passage, after public hearing thereon, at a meeting of the Delanco Township Committee to be held at the Delanco Township Municipal Building in the Township of Delanco on May 18, 2026 at 7:00 o'clock P.M. During the week prior to and up to and including the date of such meeting copies of the full ordinance will be available at no cost and during regular business hours, at the Clerk's office for the members of the general public who shall request the same. The summary of the terms of such bond ordinance follows:

**Title:** A BOND ORDINANCE OF THE TOWNSHIP OF DELANCO, IN THE COUNTY OF BURLINGTON, AUTHORIZING THE CONSTRUCTION OF MUNICIPAL IMPROVEMENTS TO TOWNSHIP FACILITIES, FURTHER AUTHORIZING THE ACQUISITION OF VEHICLES AND EQUIPMENT APPROPRIATING THE TOTAL SUM OF \$660,855 THEREFORE, AND AUTHORIZING THE ISSUANCE OF \$627,812.25 BONDS OR NOTES OF THE TOWNSHIP FOR FINANCING SUCH APPROPRIATIONS; AND MAKING CERTAIN DETERMINATIONS AND COVENANTS AND AUTHORIZING CERTAIN RELATED ACTIONS IN CONNECTION WITH THE FOREGOING.
