# ORDINANCE 2021-17

### AMENDING CHAPTER 295 GOVERNING "TRUCKS OVER FOUR TONS EXCLUDED"

**WHEREAS**, the Township of Delanco has existing provisions governing "Trucks Over Four Tons Excluded" under Chapter 295 of the Township Code; and

**WHEREAS,** pursuant to the recommendation of the Delanco Police Department, certain sections should be changed.

**NOW, THEREFORE, BE IT HEREBY ORDAINED** by the Township Committee of the Township of Delanco, County of Burlington, State of New Jersey, as follows:

# Section 1.

The Chapter 295 of the Code of the Township of Delanco is hereby amended to revise the title and content of section **295-10 Trucks Over Four Tons Excluded**, as follows:

### § 295-10 Trucks Over Certain Weights Excluded; Exceptions.

<u>A.</u> All trucks having a total combined gross weight of vehicle plus load in excess of four tons shall be excluded from all streets within the township, as well as the Field of Dreams Access Drive, 501 Creek Road, as to the entire length, except from those streets which form a part of the system of truck routes upon which trucks are permitted to travel and operate, which streets are more particularly described on Schedule VI, being attached hereto and made a part hereof by reference.

**B.** Nothing in this chapter shall be construed to prevent such trucks from making deliveries of merchandise or other property along streets from which trucks are excluded or from excluding trucks used by public utility companies for the construction, installation, operation or maintenance of public utility facilities, within the township, from any street in the township. <u>Emergency vehicles and vehicles, such as buses, engaged in the transportation of students and teams to official events shall also not be excluded from any street or Field of Dreams Access Drive, 501 Creek Road.</u>

### Section 2.

The Chapter 295 of the Code of the Township of Delanco is hereby amended to revise the title and content of section **295-37 Schedule VI: Trucks Over Four Tons Excluded**, as follows:

# § 295-37 Schedule VI: Trucks Over Certain Weights Excluded; Exceptions.

In accordance with the provisions of § <u>295-10</u>, all trucks having total combined gross weight of vehicle plus load in excess of four tons shall be excluded from all streets within the township, except from those streets which form a part of the system of truck routes upon which trucks are permitted to travel and operate, which streets are as follows:

Name of Street	Location
Burlington Avenue	Entire Length
Cooper Street – Coopertown Road	Entire Length
Creek Road	Entire Length

**Section 3. Repealer**. Any Ordinances inconsistent with this ordinance is hereby repealed to the extent of its inconsistency.

**Section 4. Severability**. If any section, subsection, paragraph, sentence, clause, or phrase of this Ordinance shall be declared invalid for any reason whatsoever, such decision shall not affect the remaining portions of the Ordinance, which shall remain in full force and effect, and for this purpose the provisions of the Ordinance are hereby declared to be severable.

**Section 5**. **Effective date**. This Ordinance shall be effective upon proper passage in accordance with the law.
