### **ORDINANCE 2015-13**

# AMENDING CHAPTER 295-4.5 GOVERNING "PERMIT PARKING" AREAS

**WHEREAS,** by Ordinance 2014-6, the Township previously adopted a new chapter to govern permit parking to address parking along the streets that intersect with Delaware Avenue; and

WHEREAS, based upon concerns expressed by the public, and specifically impacted residents that live along Delaware Avenue, the Township Committee desires to amend the provisions to make resident and visitor parking permits more readily available and easier to obtain, while still maintaining the permit parking and its attendant goals.

**NOW, THEREFORE, BE IT HEREBY ORDAINED** that Chapter 295-4.5, governing "Permit Parking" is hereby amended as follows:

#### Section 1.

# Chapter 295-4.5. Permit Parking.

- B. Application for Permit; Granting of Permit. Application for the parking permits under this subsection shall be made, in writing on forms provided by the Police Department. Permits shall be granted:
- 1. To persons who are residents on the street or designated portions thereof upon which parking is restricted by this subsection, or whose property abuts those streets even if their formal address designation indicates a different street. A resident parking permit shall be issued for up to eight (8) vehicles owned by the resident or principally operated by the person(s) who reside at such residences.
- 2. Twenty-five (25) visitor parking permits may be issued upon request to each residential unit on any street or portion thereof upon which parking is restricted by this subsection for use only by visitors to that residential unit.
- 3. The Chief of Police or his designee shall create a permit parking application form and determine the size, color and configuration of the permit, and the manner to be displayed consistent with this chapter.
- 4. In order to obtain permits, residents must apply to Police Department. There will be no charge to the resident for the cost of the permit. Permits shall remain valid unless the resident or vehicle in question is no longer compliant with the terms of this chapter. In the event of a

change in vehicle or other factors impacting the permit, it shall be the obligation of the resident to notify the Police Department.

- C. Signs. The Chief of Police is hereby directed to have proper signs posted regarding the provisions of this subsection erected or placed upon those streets or portions thereof herein described. If a sign is lost, damaged or discarded, the resident may request replacements. There shall be no cost for the issuance of resident permits, visitor permits, or replacements.
- <u>Section 2.</u> Repealer. Any Ordinances inconsistent with this ordinance is hereby repealed to the extent of its inconsistency.
- Section 3. Severability. If any provision of this Ordinance is deemed unlawful by a Court is found to be contrary to law by a court of competent jurisdiction, such provision shall be of no force or effect; but the remainder of this Agreement shall continue in full force and effect.
- <u>Section 4.</u> Effective date. This Ordinance shall take effect upon proper passage in accordance with the law.
