ORDINANCE NO. 2008-10

**AN ORDINANCE OF THE TOWNSHIP OF DELANCO IN
BURLINGTON COUNTY, STATE OF NEW JERSEY AMENDING THE
DELANCO TOWNSHIP CODE, CHAPTER 295, BY ADDING TRAFFIC
CONTROL PROVISIONS FOR THE STREETS WITHIN THE
“NEWTON’S LANDING” DEVELOPMENT**

BE IT ORDAINED by the Township Committee of the Township of Delanco in Burlington County, State of New Jersey as follows:

Section 1. The Delanco Township Committee finds that the streets within the “Newton’s Landing” development are now under Township jurisdiction and control and it is appropriate and necessary to establish traffic controls for those streets.

Section 2. The Delanco Township Code, Chapter 295, Section 295-32, Schedule I – No Parking, is hereby amended to add the following:

Section 7. The Delanco Township Code, Chapter 295, Section 295-52, Schedule XXI

- Parking for Handicapped Persons, is hereby amended to add the following:

- (6) Osmond Way Pavilion: Two spaces adjacent to and on the westerly side of the pavilion.
- (7) Newton's Landing H.O.A. Activity Complex: Four (4) spaces located in the parking area at the front of the building to the west of the Clubhouse.

Section 8. Violations and penalties. Any person who shall violate the park regulations shall, upon conviction be subject to the penalties set forth in the Delanco Township Code or otherwise provided by law.

Section 9. If a court of competent jurisdiction shall declare any section, paragraph, subsection, clause or provision of this Ordinance invalid, such decision shall not affect the validity of this Ordinance as a whole or any part thereof.

Section 10. All ordinances or parts of ordinances of the Township of Delanco heretofore adopted that are inconsistent with any of the terms and provisions of this Ordinance are hereby repealed to the extent of such inconsistency, except that any abatement granted to a residential dwelling under prior ordinance provisions shall remain in effect for exemptions and abatements granted pursuant thereto until those exemptions and abatements shall expire

Section 6. This ordinance shall take effect immediately upon its final passage and publication as provided by law.
