

**TOWNSHIP OF DELANCO**

**ORDINANCE 2024-10**

**AMENDING CHAPTER 295 GOVERNING  
"VEHICLES AND PARKING"**

**WHEREAS**, the Township of Delanco has existing provisions governing “No Parking” under Chapter 295 of the Township Code; and

**WHEREAS**, pursuant to the recommendation of the Delanco Public Works Department and the Delanco Police Department, a certain section of Rancocas Ave. in the Township of Delanco should be established as no parking during regular work week to provide access for DPW equipment to Gateway Park.

**NOW, THEREFORE, BE IT HEREBY ORDAINED** by the Township Committee of the Township of Delanco, County of Burlington, State of New Jersey, as follows:

**Section 1.**

The Chapter 295 of the Code of the Township of Delanco is hereby amended to add one location in section **295-33 Schedule II: No Parking Certain Hours** as follows:

**§ 295-33 Schedule II: No Parking Certain Hours.**

Name of Street	Side	Hours	Location
<b>Add:</b> Rancocas Avenue	North	7:00AM to 3:00PM (Monday thru Friday)	From a point seven (7) feet from Burlington Avenue to a point 73.5 feet along the northerly curb line of Rancocas Avenue

**Section 2.**

The Chapter 295 of the Code of the Township of Delanco is hereby amended to delete one location in section **295-53 Schedule XXII: Restricted Parking Spaces for Official Vehicles** as follows:

**§ 295-53 Schedule XXII: Restricted Parking Spaces for Official Vehicles**

**Delete:**

B. Pursuant to the authority granted to this municipality by N.J.S.A. 39:4-197, the following location is hereby designated as a restricted parking space for the official vehicle of the Emergency Squad Captain of the Township of Delanco:

Name of Street	Side	Location
Delete: Vine Street	East	318 Vine Street

**Section 3. Repealer.** Any Ordinances inconsistent with this ordinance is hereby repealed to the extent of its inconsistency.

**Section 4. Severability.** If any section, subsection, paragraph, sentence, clause, or phrase of this Ordinance shall be declared invalid for any reason whatsoever, such decision shall not affect the remaining portions of the Ordinance, which shall remain in full force and effect, and for this purpose the provisions of the Ordinance are hereby declared to be severable.

**Section 5. Effective date.** This Ordinance shall be effective upon proper passage in accordance with the law and upon written approval from the County of Burlington.

The above entitled ordinance was passed on first reading at a meeting of the Township Committee of the Township of Delanco on April 15, 2024 It will be further considered for final passage after a public hearing at the regularly scheduled meeting to be held on May 6, 2024 at the Municipal Building, 770 Coopertown Road, Delanco, NJ at 7:00PM at which time and place any persons desiring to be heard upon the same will be given the opportunity to be heard. Copies of this ordinance will be made available at the Municipal Clerk's office to members of the general public who shall request them.
