Mayor Ouellette took a moment to recognize any Veterans that served our Country.

Mayor Ouellette congratulated Committeewoman Kate Fitzpatrick and Joan Hinkle for winning the election last week.

DETERMINATION ON APPLICATION OF MUNICIPAL ORDINANCES FOR AFFORDABLE HOUSING FEES – Kevin Sheehan, Parker McCay

Mr. Sheehan gave a brief explanation of COAH and its implication of the fair housing act created by the State of New Jersey. The State charged COAH with identifying and notifying municipalities what their obligation was and determined rules on how municipalities could meet their obligations. COAH did this initially in six year cycles; the first ended in 1994 and the second in 1999. A discussion ensued regarding the options presented by Mr. Sheehan. Mr. Sheehan stated that the township could go with the Payment in Lieu plan or the developer fee schedule plan that has been upheld by the courts.

This determination was tabled until the next scheduled meeting on November 19, 2007.

CONSENT AGENDA ITEMS:

Mayor Ouellette questioned the amount for the longevity payments.

Committeeman Mike Templeton questioned the facility request for the Zurbrugg Mansion on 11/26/07 and 12/09/07. A discussion ensued regarding the use of the Municipal Building and the Zurbrugg Mansion. The approvals will be tabled until the next scheduled meeting on November 19, 2007. Committeeman Mike Templeton insisted on receiving a letter of approval from the Fire Marshall to use the Zurbrugg Mansion. Harry Litwack, 217 Maple Avenue suggested using the school facilities for the Women's Civic Club functions. The Township Administrator, Mr. Steven Corcoran suggested that if he could get the letter from the Fire Marshall immediately, could they proceed with the use of the Zurbrugg Mansion. MEETING OPEN TO THE PUBLIC

Mayor Ouellette opened the meeting to the public.

- 1. Marlene Jass, 4 McCay Way, asked what contractual employees were referenced in Resolution 2007-132 to receive longevity payments. The Municipal Clerk, Mrs. Janice Lohr stated that they are the Public Works employees.
- 2. William Dillenbeck, 400 Pine Street had several issues to discuss:
- stated that COAH is imposing rules and regulations on the Township and asked that as the Township increases that one of the Township requirements be that a resident be given priority when applying for employment

- reported that the flag at Gateway Park is being flown at night without being illuminated
- commented that if you increase the registration fees for dogs and cats, people will not pay for their animals and you will defeat the purpose of raising the fees feels that the fees should be left alone because it is working
- recently had a water line break in the Township and reverse 911 has been discussed in the past and nothing was ever done about it commended Mayor Ouellette and the Emergency Management Team for their help
- 3. Steve Schofield, 400 Burlington Avenue, asked:
- for a definition of a COAH unit do you get more points for a house versus an apartment?
- if the Township is receiving tax money for the PILOT agreement for Dietz and Watson for the additional improvements made to their facility
- 4. Ralph McCullough, 308 Buttonwood Street, questioned where the water main break was and questioned whether the water was safe to drink and why it is not being fixed also said there is a gas leak on Franklin Street that hasn't been fixed
- 5. Jack Hoefle, 44 Pennington Court, asked if anything has been formalized on the basin issue at Newton's Landing the Township Solicitor, Mr. Heinold stated that all the details have been outlined in a letter and he will furnish a copy to Mr. Hoefle
- asked about the bonds and their release
- asked about the (2) basins there will be no action taken until 2008
- 6. Harry Litwack, 217 Maple Avenue,
- reported that children are being chased by the Police and they have no place to "hang out" stated that children should have their say as to what they would like to do or what they need
- asked if dogs and cats are allowed to run free in Delanco Township

Marlene Jass, 4 McCay Way stated that at the last Recreation Commission meeting, they discussed having a meeting after the first of the year for the adults and children to respond with their comments and suggestions for activities for all age groups.

Committeewoman Joan Hinkle suggested having it as a discussion item for the mock election scheduled for the next Township Committee meeting on November 19, 2007.

MEETING CLOSED TO THE PUBLIC

Since there were no further comments or questions from the public, Mayor Ouellette closed the meeting to the public.

The Township Solicitor, Mr. Douglas Heinold requested that Henry Kent Smith, representative for Creekside at Delanco, be heard before they proceed with the next item on the agenda.

CREEKSIDE AT DELANCO – PROPOSAL FOR STORMWATER FACILITY MAINTENANCE AND EASEMENT – Henry Kent Smith

Mr. Smith stated that he was here tonight to discuss with the Delanco Township Committee the proposal at Creekside and how they are proposing to address certain maintenance of various facilities that are part of that development. Mr. Smith exhibited a drawing of the proposed plan they have for Creekside. Mr. Smith stated that the easements will be imposed on the individual homeowner. The homeowner's responsibility would be limited to the surface of the basin. There would be two

restrictions: no structures or any impediment to storm water flow and that they maintain the grates free and clear of debris. Mr. Smith stated that he is requesting that the Township Committee consider this and allow for the easements to be dedicated to the Township so that they can proceed to commence the construction improvements and ultimately complete the project. Mr. Smith concluded that they would like the Township Committee to consider the storm water management and drainage facilities easements so that the facilities would be owned by the homeowners and the underground facilities and pipes underneath the ground would be owned by the Township. The maintenance obligations for the surface go to the home owners and what is underneath the surface goes to the Township and there is a mechanism for cost recovery in the easements. A discussion ensued with questions and answers from the public and the Township Committee members. The Township Solicitor, Mr. Douglas Heinold stated that there are two options: (1) an HOA that would be responsible for all the easements and their assessments (2) the Township would deal with it directly as the subsurface and their issues

Mr. Smith stated that a disclosure notice will be supplied to anyone that is considering buying a lot at Creekside. The disclosure notice will have all the easements listed. Mr. Smith stated that they want to proceed on this and if they don't get an answer by next week, the default will be an HOA for Creekside at Delanco.

The Township Committee members, the Township Solicitor and the Township Engineer will review the information provided by Henry Kent Smith regarding Creekside at Delanco and provide their answer to the request at the next scheduled Township Committee meeting on November 19, 2007.

CORRESPONDENCE – Mrs. Janice Lohr – Nothing to report

Committeewoman Kate Fitzpatrick asked the Municipal Clerk, Mrs. Janice Lohr if she received a letter from Bao Radcliffe inquiring about the position available and commented that there is a vacancy on the Historic Preservation Advisory Board and asked if they could approve his interest on this board. Mayor Ouellette suggested the members review the letter and make a decision at the next scheduled Township Committee meeting on November 19, 2007.

DISCUSSION ITEMS:

1. RECEIPT OF PROPOSALS FOR PURCHASE OF MANSION

Mayor Ouellette stated that they received several RFP's for the Mansion. A discussion ensued. Committeewoman Kate Fitzpatrick suggested that they choose which proposals they want to review and invite the individuals to an open meeting to discuss them. The Township Administrator, Mr. Steven Corcoran stated that he will compose a letter to the applicants and invite them to a Township Committee meeting to give their proposals. They will invite three for the November 19, 2007 Township Committee Meeting and three for the December 3, 2007 Township Committee Meeting. The applicants will be given a half hour to present their proposal for the Mansion with a question and answer period following the proposal. Then the Township Committee members will score the proposals and discuss the scores after the presentations.

MEETING OPEN TO THE PUBLIC

Mayor Ouellette opened the meeting to the public.

- William Dillenbeck, 400 Pine Street, commented that one of the worst things you can do is bring three potential buyers together and suggested that they bring them in one at a time so that you don't intimidate anyone.
- Harry Litwack, 217 Maple Avenue, commented that he did not understand the score card rating before they are hearing the presentations.
- Steve Schofield, 400 Burlington Avenue, asked if there was one proposal that stood out among the rest.

MEETING CLOSED TO THE PUBLIC

Since there were no further comments or questions from the public, Mayor Ouellette closed the meeting to the public.

2. 2006-2007 CAP WAIVER – Township Administrator – Mr. Steven Corcoran

Mr. Corcoran explained the cap waiver process and stated that there are new regulations that will penalize the Township for any amount in the cap waiver that is unexpended. Mr. Corcoran asked the Superintendent of Public Works, Mr. John Fenimore if he would comment on three items that would take about \$38,000-39,000 of the \$60,000 the Township had leftover from 2006 that can be carried over for one year only. A discussion ensued. Mr. Fenimore stated that he needed: (1) Salt Spreader (2) Tractor and (3) Snow Plow for the loader

Committeeman Mike Templeton asked if this \$60,000 shows up in the 2007 budget.

3. CREEKSIDE AT DELANCO – PROPOSAL FOR STORMWATER FACILITY MAINTENANCE AND EASEMENT – Discussed previously in meeting

4. PROPOSED RESOLUTION TO EXTEND SOLID WASTE COLLECTION CONTRACT WITH SOUTH JERSEY SANITATION – Township Administrator – Mr. Steven Corcoran

Mr. Corcoran asked if this could be carried over to the next scheduled Township Committee Meeting on November 19, 2007 when the mock election winners will be present so they can work on it. Mr. Corcoran stated that this is an extension of the original three year contract with South Jersey Sanitation. However, this would be the first of a potential two year extension. The service level would remain the same and there is only a 1.02% increase. Mr. Corcoran stated that he would like the Township Committee to opt on the one year extension to the existing South Jersey Sanitation contract. Deputy Mayor Ed Devinney questioned the Township Administrator as to the once a week as opposed to twice a week garbage pick-up. Mr. Corcoran stated that they did research this idea and the cost savings to go from two days to one day was not significant. The Township Solicitor, Mr. Heinold added that he has actually seen where a Township was seeking a one day pickup as opposed to a two day pickup, and the bid came out higher for the one day pickup.

Motion by Ed Devinney, seconded by Joan Hinkle to authorize the Township Administrator to contact South Jersey Sanitation to extend the existing contract for one year and the resolution will be memorialized at the November 19, 2007 Township Committee Meeting.

• Mr. Heinold stated that he received a call from Thomas Coleman who advised him that he would be contacting the Township Committee regarding the Coopertown Road issues. Mr. Heinold stated that it was their intention to get the letters out to the end users by the end of the year.

COMMENTS – TOWNSHIP ADMINISTRATOR – Mr. Steven Corcoran
