WHEREAS, the Annual Budget and Capital Budget for the Delanco Sewerage Authority for the fiscal year beginning, January 1, 2020 and ending, December 31, 2020 has been presented before the governing body of the Delanco Sewerage Authority at its open public meeting of October 8, 2019; and

The following appropriations increased/decreased by more than 10%:

Administration salaries increased by \$8,000 or 15.1%. The Treasurer/Secretary received an increase for increased duties with less staff support.

Operations salaries decreased by \$20,000 or -28.6%. The former executive director was replaced. The new executive director is earning significantly less salary.

Professional services decreased \$21,012 or -58.3% due to reduction in engineering costs.

Interest payments on debt service decreased \$4,800 or -18.8% due to reduction in outstanding principal.

The local /regional economy has remained relatively stagnant.

The proposed 2020 Budget is utilizing \$217,856 in the proposed Annual Budget and \$100,000 in the proposed Capital Budget to balance the budgets.
