PLEASE TAKE NOTICE, that in accordance with the Open Public Meetings Act, N.J.S.A. 10:4-6 et seq., and in consideration of Executive Order Nos. 103, 104, and 107 issued by Governor Murphy, declaring a State of Emergency and a Public Health Emergency in the State of New Jersey, the Township of Delanco does hereby notify the public that to protect the health, safety and welfare of our citizens while ensuring the continued functioning of government, the 2022 regular monthly meetings of the Joint Land Use Board scheduled at the Delanco Municipal Building, 770 Coopertown Road, Delanco, New Jersey at 7:00 PM will be held electronically via Zoom until such time as the Township determines that conditions permit the Board meetings to be conducted in person.
