## **Waterfront Park/Gateway Park Rules and Regulations**

1. Gazebo/Pavilion will be open for use from 9AM to dusk.
2. Maximum capacity is 25.
3. Alcoholic beverages, vaping and smoking are prohibited.
4. Bounce houses, blow up rides, or amusement rides are NOT permitted in the park.
5. Food trucks are prohibited.
6. Absolutely no motorized vehicles of any kind are allowed anywhere in the park, except in designated parking areas. Exceptions to this rule are wheelchairs, emergency and maintenance vehicles.
7. Bicycle riders must extend the right of way to pedestrians in all areas of the park, keeping to the right at all times. Excessive speed or racing is prohibited.
8. Dogs must be restrained on a leash. Clean up after your dog.
9. There is no access to water anywhere in the park.
10. All trash and recycling must be contained after use of the pavilion/gazebo.
11. Smoke cannons, confetti poppers, balloon popping and releasing of balloons are not permitted.
12. No tents, temporary structures or setup of chairs allowed, you are only permitted to use the pavilion.
13. You must request a refund 7 days before your reserved date, refunds will not be given due to bad weather
14. All rules and regulations cited on this sheet and in Township Code 216-2.1 will apply.  
Violators will be prosecuted to the full extent of the law.
15. No swimming.
